Clerk of the Circuit Court, Rockingham County***

The Shenandoah Valley Civil War Round Table, along with a generous gift from the Rockingham Cluster Group of the Shenandoah Valley Battlefields Foundation, is delighted to support the preservation efforts of Clerk of Court Chaz Evans-Haywood in restoring and conserving an historical volume titled "Civil War Veterans." Found in the basement of the Court House, this volume is a roster of the names of the Rockingham County soldiers who fought in the Confederate Army. To ensure the pages are protected long term, a nationally-known preservation company cleaned, de-acidified, and protected the pages in preservation-grade mylar. Electronic copies of this treasure have been gifted to The Heritage Museum for public access beyond the Court House.
